## Security Test Your Security

It's easy to install PC security software, but how do

<u>Security</u> <u>Intermediate</u> <u>Problem-</u> <u>Solver</u> ecurity software, but how do you know that you're really protected? After spending \$40 to \$80 for security software, it's important to know that the software is actually

doing what it's supposed to be doing—and most users would rather not test their security with a real attack. Fortunately, today's security software typically includes testing tools that can remotely inspect the most common areas of attack and help you identify risk areas. This month's article covers the steps to help you configure and use security testing tools with NIS (Norton Internet Security) 2007.

#### **Step 1: Run A Complete Scan**

Be sure to configure the security testing feature to test as many common vulnerabilities as possible. As an added precaution, it's a good idea to start a security test with a complete scan for viruses and spyware especially if you're not performing complete scans on a regular basis. An initial virus/spyware check can identify infections that might compromise your security even before you actually

perform security testing. Be sure to update any virus/spyware signature files so that you are protected against the latest threats.

#### **Step 2:** Access The Testing Tool

Be proactive. Security tools are improving every day, but attacks succeed because users aren't prepared. Just as an antivirus checker should warn you about viruses before they have a chance to strike, it's important to test your security regularly so that you can see potential vulnerabilities and take action before a real attack occurs. If your security software includes integrated testing features, open the security control panel and select the testing feature. For NIS 2007, this is called the Security Inspector.

#### **Step 3: Configure The Test**

Before invoking a security test, be sure to configure the testing feature so that it checks for common security oversights, such as vulnerable passwords, weak browser security settings, IP (Internet Protocol) addresses, shared folders, and other typical security issues. For NIS 2007, click the Configure button, select the Security Inspector tab, and then click the Settings button under Categories. Select the Basic Scans tab and make sure that all the checkboxes are selected. Now, select the Advanced Scans tab and select those checkboxes, as well, to guard against improperly shared folders, accounts with excess rights, and incorrectly configured Windows services. Click OK to save your changes.

As an added measure of security, click the Configure button and select the Firewall tab. Locate the Advanced security settings area at the bottom of the dialog box and be sure to select the Stealth Blocked Ports option. This will effectively hide any ports on your PC that are not specifically being used for communication, effectively lowering the visibility of your PC to potential attackers. Click OK to save any changes.

Once vulnerabilities are identified, you can take steps to fix them or make other adjustments to protect the system.

#### **Step 4: Scan For Vulnerabilities**

Once the security testing feature has been configured, it's time to run a scan. For NIS 2007, click the Scan Now button. Each security area will be scanned, and any vulnerabilities found will be reported in a list. Click the Details link to see a detailed description of the vulnerability. In many cases, the security tool can even help you fix the vulnerability so that it cannot be exploited by an attacker.

In our example, NIS identified two folders that should not be shared, and it also found a weak or missing administrator password. Click Details to see the compromised shared folders and change their sharing settings. NIS cannot fix a password, but you can go to the Control Panel and select a new, stronger administrator password to secure the system. Once you've made changes, rerun the test until the system reports no vulnerabilities.

#### Step 5: Run An External Test

Up to now, you've only tested the PC's internal security against common vulnerabilities, but how does the system fare in a simulated attack? Some security testing tools can access an external testing feature that will examine the system's security looking in from the Internet. For example, NIS 2007 can access Symantec's testing site. With the main security control panel open, select the Security entry and then click the Check Security button. This opens a Web browser. Click Start in the browser window, accept the EULA (End-User License Agreement), and download any ActiveX controls needed to run the test (this can take a few minutes). The tests will then start to examine your computer externally (this process can also take several minutes, so be patient). Once the test is completed, you'll receive a report summary that identifies any potential risks from hackers, windows vulnerabilities, and Trojan horses, along with a check of the antivirus protection. Any risks will be accompanied by suggestions for corrective action. If the report checks clear, you can be confident that your PC is reasonably well-protected.

Comcast CEO shows off super quick modem

LAS VEGAS - Comcast Corp. Chief Executive Brian Roberts dazzled a cable industry audience Tuesday, showing off for the first time in public new technology that enabled a data download speed of 150 megabits per second, or roughly 25 times faster than today's standard cable modems.

The cost of modems that would support the technology, called "channel bonding," is "not that dissimilar to modems today," he told The Associated Press after a demonstration at The Cable Show. It could be available "within less than a couple years," he said.

The new cable technology is crucial because the industry is competing with a speedy new offering called FiOS, a TV and Internet service that Verizon Communications Inc. is selling over a new fiber-optic network. The top speed currently available through FiOS is 50 megabits per second, but the network is already capable of providing 100 Mbps and the fiber lines offer nearly unlimited potential.

The technology, called DOCSIS 3.0, was developed by the cable industry's research arm, Cable Television Laboratories. It bonds together four cable lines but is capable of allowing much more capacity. The laboratory said last month it expected manufacturers to begin submitting modems for certification under the standard by the end of the year.

In the presentation, ARRIS Group Inc. chief executive Robert Stanzione downloaded a 30-second, 300-megabyte television commercial in a few seconds and watched it long before a standard modem worked through an estimated download time of 16 minutes.

Stanzione also downloaded the 32-volume Encyclopaedia Britannica 2007 and Merriam-Webster's visual dictionary in under four minutes, when it would have taken a standard modem three hours and 12 minutes.

"If you look at what just happened, 55 million words, 100,000 articles, more than 22,000 pictures.

maps and more than 400 video clips," Roberts said. "The same download on dial-up would have taken two weeks."

Other cable industry executives, including Time Warner Inc. Chief Executive Richard Parsons, News Corp. President Peter Chernin and Viacom Inc. Chief Executive Philippe Dauman, cheered the demonstration during a panel afterward.

Brian Dietz, spokesman for the conference host, the National Cable and Telecommunications Association, said the demonstration was the key technological advance showcased at the conference.

"It's an exponential step forward and we're very excited," Roberts said. "What consumers actually do with all this speed is up to the imagination of
