

## embedding true type fonts **WORD**

If you create a document that you want to share with others, it is helpful for the other people to have the fonts you use within your document. If they don't have the fonts, then Word substitutes a similar font for the original fonts

you used. The result may not be to your liking. One solution is to include the fonts with your document. You can automatically embed some types of fonts by following these steps:

1. Choose Options from the Tools menu. Word displays the Options dialog box.
2. Make sure the Save tab is selected. (Figure 1.)



- 3. Ensure the Embed TrueType Fonts check box is selected.
- 4. If you will be using a small number of characters in a particular font, choose the Embed Characters In Use Only check box.
- 5. To save space in the document, choose the Do Not Embed Common System Fonts check box.
- 6. Click on OK.
- 7. Work with your documents as normal.

You should realize that embedding fonts can increase the size of your document files. In fact, if you use a lot of fonts, it can increase the size drastically. In

addition, not all fonts are "embeddable." Some fonts are protected by their creators against distribution by embedding. If you are curious about whether a particular

font can be embedded, you can either contact the vendor or download a free Font Properties Extension Tool from Microsoft. You can download it at the

following address:

http://www.microsoft.com/typography/ TrueTypeProperty21. Mspx

The tool updates Windows so it displays more information when you right-click on a font file and choose Properties. One of the pieces of information displayed is whether the font is protected

or not. If it is protected, it cannot be embedded in a Word document.

## should I buy a network attached storage device?

Orange County Users Group January 2014 ToNAS or not to NAS? That was the question I asked myself while planning for a new computer. I've always gone to great lengths to have good data backups. In the days before hard drives, I used to have two boxes of 5 1/4" floppy disks; one for my

original files and one for backup copies. After getting my first hard drive, I still used one box



of floppies to back up any new or modified files. I eventually converted to flash drives, but was still careful to always have backups. This approach meant saving everything twice, but I never lost a file.

#### Synology DS209

A network attached storage (NAS) demonstration at an Orange County PC Users' Group meeting a few

years ago convinced me to get a NAS at home. Since a NAS is a special hard drive enclosure designed to

robustly back up and store files redundantly, it can be a valuable way to protect data.

After research, I bought a Synology DS209, primarily based on good customer reviews and three USB ports. I thought connecting my laser and ink jet printers to USB ports on the NAS might be a convenient way to put them on my home network. I also periodically connected an external hard drive to one of the USB ports to back up the NAS.

Although my main interest is data backup, this NAS (and many others) can also act as a mail

or web server and share files on a network. For redundancy, I chose two drives configured to "mirror" each other. Whenever I saved a file to the NAS, it was written to both drives.

Setup was straightforward but, as at least one Amazon.com reviewer mentioned, probably not for a novice. My computer and networking background made the concepts and terminology familiar. The biggest issue for me was that my computer wouldn't always recognize the NAS on daily start up. I had an Ethernet connection and accessed the DS209 by IP address. Synology's technical support recommended "mapping" it to a drive letter, which solved the problem. The only other issue I've had with the DS209 occurred following a power failure. All three of the USB ports died and have not worked since.

The NAS came with backup software but I chose to use a program called "Karen's Replicator" that I read

about in the "Windows Secrets" newsletter. I simply set it to copy all new or modified files from my PC hard drive to the NAS once per day.

While planning for my new computer, I wondered if it made sense to continue using the NAS for mv

backups. As an experiment, I installed a USB3 card (for speed) in my then current PC and connected two external USB3 hard drives. With Karen's Replicator, I scheduled a backup for one drive in the morning and the other in the evening. After running all of these backups for several months, I concluded that the USB3 hard drives were giving me accurate backups without the extra complication of the NAS. I also began alternately swapping a different drive each week and taking the "removed" drive off site for safety. Since I hadn't been using most of the sophisticated features of the NAS, this is the method I'm using with my new computer.

Which method is best for you? Like so many alternatives we encounter, it depends. If you want to share

the device with multiple computers, or set up a web or mail server, the NAS is definitely better. If you simply want to backup the data from one PC, the external drives are easier to implement and maintain.
